Hely (Ret.), Hearing Officer for the Peace Officer Standards and Training Commission. The Appellant is required to appear even if represented by counsel. Please note that the adjudicatory hearing will be recorded.

Guidance for Court Procedure:

The hearing will begin promptly at 9:00 a.m. The hearing will be conducted according to the formal adjudicatory rules of practice and procedure outlined in M.G.L. c. 30A, § 10, 801 CMR 1.00, and 555 CMR 1.10. All persons present should conduct themselves in a manner consistent with the standards of decorum commonly observed in court. Where such decorum is not observed, the Hearing Officer may take appropriate action.

All individuals, including law enforcement officers, are prohibited from possessing weapons, including firearms, in Commission offices and facilities designated to conduct Commission business.

Please submit the following items to POSTCReview@mass.gov, with the subject line, “*In the Matter of G.B.* (Case No. 23-002-C),” and a copy to the opposing Party no later than **5:00 p.m. on October 17, 2023:**

1. An electronic copy of exhibits in PDF form. **It is important to follow the instructions in the scheduling order** regarding the format of the exhibits, including the need to:
 - a. redact all personal identifying information;
 - b. submit separate exhibits, each with a title page that includes the number and title of the exhibit;
 - c. insert Bates numbers on the bottom right corner of the exhibits.
2. A separate exhibit list. Please use the document that was forwarded to you.
3. A separate participant list. Please use the document that was forwarded to you.
4. Any remote witnesses will be sent a Zoom link the day before the hearing. Please send the Hearings Administrator a list of any remote witness and their email address.

No continuances will be granted except for extraordinary circumstances. Failure to appear without a showing of good cause will result in default of the appeal or possible dismissal of the appeal, as appropriate.
